This 2023 Winter Camp Operations Guide is provided to you as a resource. It's important for us to communicate our response to the COVID-19 pandemic, and share our efforts to care for your child's health and safety.

Santa Fe Children's Museum is CDC-compliant and since March 2020 has made changes to keep you, your family, and our staff safe and healthy. Some of the new operations include encouragin staff, interns and volunteers to be vaccinated, being outdoors as much as possible during programs and camps, adjustments to exhibit availability, upgrades to our HVAC system, and the purchase of new hospital-grade air purification systems.

As of February 17, 2022, New Mexico does not require face masks in all indoor spaces. This policy applies to our guests, staff, and volunteers. However, everyone may continue to wear a mask to protect themselves and others from getting COVID-19. If you feel more comfortable with your child wearing a mask, that is ok! Masks must be provided from home.

We will continue to monitor and modify all recommendations to ensure that all visitors have a comfortable experience at the Santa Fe Children's Museum. At the heart of all the policies of SFCM is abiding by the mission to keep all of your campers and staff are equitably healthy and safe.

We remain committed to delivering a fun and educational camp experience for all!

Camp Refund Policy

All registrations canceled two weeks or more prior to the week of the camp start date will receive a refund minus the \$100 deposit. Cancellations within one week of the camp start date will only be refunded, minus the \$100 deposit, if the camper's spot can be filled from the waitlist.

The same cancellation policy is in effect for campers on a full or partial scholarship, however, the non-refundable deposit is \$25

Drop Off & Pickup

- Only one adult may walk children in for drop-off.
- Please respect distance between families entering.
- A delayed start time may be deemed necessary in the event of inclement weather. If so, families will be notified via email and text message.
- Parents will drop off through the Museum main entrance between 8:45 am 9 am. Parents must escort their camper into the building and sign them in each day.
- Parents will pick up campers from our Sculpture Garden located in front of our Museum Office Entrance. (Due to tentative <u>construction</u>, we are unable to use the same exit procedure as in previous years.) Campers who stay for Aftercare are to be picked up using the main entrance and sign out through the front desk.

Aftercare and Late Fees

- \$15 per day/per camper (\$12 per day/per camper for additional sibling)
- Available daily from 3 pm 5 pm
- Any camper not picked up by 5:30 pm, will incur an additional \$1 per minute late fee.
- Families picking up children from aftercare will use the Main Entrance. Give your child's name to the Front Desk and make any needed payments. Your child will be walked forward by a camp staff or Youth Mentor.



Campers

- Campers may be ages 5-9 (*Must be potty trained*)
- Each child will be provided their own individual supplies to complete projects and a selection of toys to use for the week.
 Supplies will not be shared outside of camp.
- Campers will receive a Health and Safety Orientation as part of the curriculum every first day of camp.
- Campers who repeatedly do not respect any of our camp policies, will have their parent/guardian called and may be dismissed from camp.

Materials & Personal Property

- Filtered water will be available.
- No use of microwave will be permitted.
- Please label all personal items, jackets, hats, lunchboxes, etc. with the camper's name.
- Children will spend time outdoors and classroom temperatures can fluctuate, so please dress in layers.
- Kids getting creative can get messy, please dress accordingly.
- No electronics, please. Any valuable toys or items should be left at home. SFCM is not responsible for lost, stolen, or broken items brought from home.

STRUCTURE



- 16 children: 1 adult ratio. 1 Youth Mentor per every 4 campers.
- Children will be in the same group and with the same staff member and youth mentor each day
- Mask-wearing regulations for campers will follow that of students in Santa Fe Public Schools. At this time, the Santa Fe Children's Museum highly encourages mask-wearing for all, but it will be optional for campers, staff, and Youth Mentors. Proof and/or knowledge of vaccination status is appreciated, but also not required for camp participation.
- Any child, staff, or youth mentor experiencing symptoms of illness is asked to stay home.
- Best practices for hand hygiene will be followed
- All toys and costumes will be disinfected between use.
- Eating times will be outside when possible in our outdoor classroom.

Food and Drinks

- Campers will eat outdoors when at all possible.
- Drinking from fountains is prohibited. Campers may use the sink to refill water bottles.
- Campers must bring their own personal water bottles. Please mark with the camper's name in large letters!
- Every camper must bring their own lunch and a snack each day. Peanut-free preferred.
- We recommend packing additional snacks for campers staying for aftercare.

Cleaning and Disinfecting

- A janitor/cleaning service will complete a full sanitization of the museum after each camp day.
- Cleaning team completion records will be used.
- Camp tools and toys will be disinfected daily.
- If an area or object needs attention, we encourage our campers to notify our staff right away.
